Please sign and date this form and mail, fax, or bring it with you to The Wilderness.

(If you are the **leader** of a group or family planning to use TWFM, it is necessary that you present this information to your group or family.) **All vehicles driven by your group must enter the property at 22000 Cty Rd M, Frederic, WI 54837**

All persons, families, or groups, must provide their own health and accident insurance when on The Wilderness Fellowship Ministries property or at an event sponsored by TWFM.

If you are unable to comply with all these guidelines or desire some variance, please ask us to consider your request **prior to your arrival.**

FOR YOUR SAFETY, AND THE SAFETY AND RESPECT OF OTHERS, WE DO HAVE A FEW ABSOLUTES

1. **NO alcoholic beverages or other drugs**
2. **NO fireworks of any kind are allowed**
3. **NO firearms of any kind (If you are licensed to carry you must talk with Randy for approval to carry while here)**
4. **NO SMOKING in or near the buildings or on the trails.**
5. **NO pets allowed in the buildings or on the grounds** (exception: service dogs; please notify prior to arrival)
6. **NO TV's, radios, personal electronic devices, except for ministry leader use**
7. **NO candles**

ARRIVAL & DEPARTURE DATES AND TIMES

1. It is **very important** for us to know your arrival time, especially if you are arriving **after** our regular office hours, about 5:00 P.M., Monday through Friday. We have set aside a time to greet you and help you get settled into your cabin **at the time you told us you would be arriving.**
2. **If you are going to be later than your scheduled arrival time, please let us know what time you will arrive.**
3. Check out time is 12:00 noon unless special arrangements have been made with the office.
4. **Please take note of the cancellation/no show policy regarding the facility you reserved; it is in your confirmation email and posted on our website.**

VEHICLES

1. Always drive slowly on the grounds, and watch for children.
2. Please park in designated parking areas only. Please obey posted signs.
3. Please avoid unnecessary driving. Leave your vehicle parked once you arrive at your site if at all possible.
4. Do not park in front of buildings or on the grass (exception: Lakeside Cabin).
5. Please stay on the main roads to your destination.

CARE & USE OF FACILITIES

1. Please camp only in the area that you have reserved.
2. The showers / bathrooms in the FFRC are intended for use by FFRC retreatants only.
3. The Prayer Cabin Village Showers /bathroom are for Prayer Cabin guests only.
4. You will be held responsible for paying the cost of repair or replacement of any Wilderness property damaged, lost or broken by your group.

ACTIVITIES

1. In the summer the beach is open. However, TWFM does not provide a lifeguard. Children must be accompanied by an adult.
2. **Modest swim apparel is required. No bikinis or bare tummy swimsuits.**
3. When using the boats, canoes, or other water equipment, life jackets must be worn at all times.
4. When fishing, all Wisconsin fishing laws apply.
5. Swimming, boating, canoeing, water skiing, snow skiing, skating, and all other activities are all done **AT YOUR OWN RISK. TWFM does not provide insurance for you. You and your group must assume this responsibility.**
